Penalty Computation	
A.	For failure to file a return on time, with no tax due , the penalty is \$50.
B.	For failure to file a return on time with tax due , the penalty is: 1-60 days late , 10% of the tax due for the first month plus 1% of the tax due for each month thereafter, but in no instance less than \$50.00, 61 or more days late , the greatest of the following: — 10% of the tax due for the first month plus 1% of the tax due for each month thereafter not to exceed 30% or — the lesser of \$100 or 100% of the tax due, or — \$50
