Please be sure to sign-in at all sessions that you attend for continuing education (CE) credits. CE credits will also be used to determine your eligible expenses for reimbursement.

*In addition, overnight expenses are available to those eligible who travel over 50 miles from their official stations to the conference.

The maximum number of overnights that will be reimbursable for this Conference is 3 nights.

Vouchers must be received by ORPTS within 30 days of the conference. Reimbursement rates for Albany County Hotel =\$114 per night (must have itemized receipt). Mileage = \$.67 per mile and tolls. Rates are subject to change. Reimbursement will be provided from the Third Training Period (December 1 – March 31). Reimbursement for continuing education may be prorated. Rules allow ORPTS to reimburse a percentage of the expenses when funds are insufficient to cover all expenses.
